I. Approval of June 13 LT Minutes

II. Update 5th/6th Street Study: Caleb & Ben

Ben Weiss updated the LT that he had recently spoke with Joe from Alta Consulting. There are 3 alternatives to address the issues: 1.) Single lane traffic; 2.) 2- way conversions; & 3.) Leave as is, possibly removing parking. Joe from Alta Consulting communicated that the preliminary runs have shown the timed signals with a single lane is not working. Joe asked if he could adjust the light times and Ben referred him onto the Montana Department of Transportation. Recommendations will be presented at 2 public meetings. At the first meeting the consultant will present alternatives, develop pros and cons, and collect the information gathered. The second meeting will be a presentation of the preferred alternatives, and identify next steps. This process should start in late August/early September.

IV. Proposal for Neighborhood Signage: Jeff

Jane will do some more research on the possibilities of signage. She is going to send a photo of the Westside sign and mentioned they were able to get approval because it was not a "wayfinding sign."
