### **City Solicits Ideas for Housing and Community Development Projects**

The City of Missoula and Missoula County are beginning the annual process at a community needs assessment meeting to gather public opinion on the needs of the Missoula community and to collect suggestions for potential community projects. The City also uses this meeting to develop a list of needs for the money it will receive from the U.S. Department of Housing and Urban Development (HUD) for housing and community development projects. Projects must assist low- and moderate-income residents or neighborhoods. The money may be used to expand, maintain or improve the supply of housing; offer human services, promote economic development; and construct or rehabilitate public infrastructure.

The community needs assessment meeting will be held Tuesday, Jan. 13, from 4 to 6 p.m. in the Missoula City Council Chambers at 140 W. Pine St. The public is invited to attend to express their ideas for the community's needs in the city or county or to propose potential projects for funding.

Missoula will receive grant money in federal fiscal year 2015 through the Community Development Block Grant (CDBG) and the Home Investment Partnerships Program (HOME) programs. The City will reserve part of the available funds to undertake activities that promote fair and affordable housing and to manage the programs. The City will accept applications for

CDBG and HOME funds from community groups through an application process that begins with an application workshop on Jan. 14.

“CDBG and HOME and our partners have brought about fantastic projects for Missoula,” Mayor John Engen said. “The funds have helped provide food, shelter, infrastructure like sidewalks and sewer, medical care, housing, child care, and many other services for low- and moderate-income residents and neighborhoods. Missoulians have the opportunity at this meeting to share their ideas and hopes for other ways to strengthen our community.”

Missoula has developed specific objectives for its CDBG and HOME allocations in the Missoula’s 2014-2018 Consolidated Plan, adopted by the City Council in June 2014. Pre-application proposals for the CDBG and HOME funds will be accepted until Feb. 2. Applications are due March 9.
