REMOVAL OF ABANDONED OR UNWANTED VEHICLES FROM PRIVATE PROPERTY

Montana Law provides the following options for removal of abandoned or unwanted vehicles from private property.

If you own the vehicle, contact the Missoula City-County Health Department to request removal of the vehicle.

Requirements: Proof of ownership (title, registration, etc.) of the vehicle
Sign ownership over to the Junk Vehicle Program
There is no charge for removal; and vehicles in any condition or state of repair may be removed under this program.

If you do not own the vehicle, Montana Statute (MCA 61-12-401) permits the removal of vehicles from private property at the request of the landowner or person in lawful possession or control of the private property, by the city police. The vehicle must have been on the property for at least five days (120 hrs) before law enforcement may remove it.

Program Requires: Completion of form by property owner or manager requesting removal and agreeing to indemnify Police against any claim that the vehicle was lawfully on the property

Return form to the Missoula Police Department

Once this form is received, a representative of the Police Department will then tag the vehicle, which will be towed if not removed by the owner. There is no charge to the requesting property owner for the removal.
