1. How will request assist in acheiving Department Goal and benefit the customer?

Request to purchase a critically needed new 1-Ton Truck that will have a removable 400 Gallon Water Tank w/ Pump and hose lines, and also include a removal road and pathway sander allowing the vehicle to be used all year. The Missoula community has an aging urban forest that is essential to the environment and the health and wellbeing of our community members. We currently plant several hundred trees per year which require weekly watering for the first two years of their life. Without this frequent watering, they will suffer a high mortality rate costing our community members. Our conservation land management program also requires the use of the watering truck for dozens of green projects every year that must also be sustained with water.
