Summary Description and rationale of project and funding sources:

New park, trailhead, river access and gateway to Milwaukee Trail west across the Clark Fork River, connecting to Mullan. Initial development of the park area would include turf, irrigation, trees, soft surface trails and natural areas. Phase two would include a small picnic shelter and playground, as well as a trail kiosk. Currently \$120K of Impact Fees is approved for this project.
