### 3. Presentations

#### 3.1 Higgins Ave. Corridor - Ben Weiss, Transportation

Charlie Menefee, City Transportation gave an overview of the Higgins Corridor plan which kicked off the summer of 2021 and gained community vision. In Sept. 2022 the plan was developed with the vision and concept designs. The Department of Transportation (DOT) has jurisdiction over the road and selected and supports the designs. He showed a presentation including Project Goals with a safer design and economic activity. There is policy support backed by the City Council. He discussed the details of the plan.

He noted the Beartrack Bridge known as the Higgins bridge will affect the project.

The plan's benefits will reduce crashes by 50%, the lane widths will be widened and will improve maintenance & emergency access.

Trade-offs in decision includes motor vehicle safety, parking, pedestrian comfort, transit access, bicyclist safety, and streetlight data.

There was public outreach and the City received many comments and emails, and the results included mixed opinions. There were many mixed results from the businesses.

The Public Works committee will discuss this project on Feb. 1, from 1:00 pm to 2:30 pm located at the City Council Chambers, if approved the City Council will approve it at their City Council meeting on Feb. 6, 2023. The project will begin in 2025 - 2026.

There were questions regarding parking loss, traffic light synchronizing, and federal grant funding.
