Jack called the meeting to order.

November meeting Minutes were approved.

Lee presented the rough draft of our Neighborhood Action Plan.

This Plan was created during 2 M.C. Leadership Team meetings, and 1 informal conversation. 962 comments from our survey are included.

Priority #1: Traffic management & Emergency Preparedness.

- recruit 6 Miller Creek Residents to schedule a meeting with City officials to discuss Traffic Opportunities & Evacuation routes for emergencies.

Priority #2: Maintain and enhance parks, recreation, and open spaces.

- recruit 6 M.C. Residents to schedule a meeting with City officials to discuss development and maintenance of parks and open spaces.

- create agreements with City, County, HOAs, and Developers. City vs County properties need to be clarified.

Implementation Plan:

- time frame for completion would be approximately 3/4 of the year, (2025).

The Action Plan would include a Public Comment meeting.

Neighborhood Report given by Melissa:

The Grant Awards will be announced in March.. Anyone who would like to be on the Grant Committee is welcome. Contact Melissa or Kalina.

Local Government Academy applications are open for 2025. Classes are 6 Thursdays (6 weeks); 6-9 pm. It starts in February.

The possibility of a Public Comments meeting was discussed regarding an SID in the Maloney Ranch area. A closer look at the project could be presented at that time. It was suggested this meeting be held in February.
