Miller Creek Neighborhood Council Leadership Team Meeting Minutes

March 18, 2025; 6pm

Minutes of the January and February meetings were approved.

Jack attended the ULV HOA meeting. He handed out copies of our General Annual Meeting survey and summary results that we collected.

The HOA is to provide a person for Brooke Lynn park oversight of maintenance. There's supposed to be a trash can at parks that the City would provide for clean out services, but this isn't happening. Boulevard trees are to be planted and it has been determined that the Developer should be responsible for the landscaping and care. A picnic table has been provided at Brooke Lynn park. Neighborhood Leadership Team would like to place a Message Board in close proximity to the mailboxes at Brooke Lynn park. The HOA voted to let the MC Leadership Team maintain the message board. The HOA was interested in the Leadership Team information regarding a green turn signal light at Hwy 93 exiting Miller Creek. Special Improvement District boundaries were discussed at the Upper Linda Vista HOA meeting.

Jen Pfeiffer will be our Community Forum person. The topic at the March meeting will be in regards to Neighborhood Grants.

Action Plan Discussion:

Alex moved that our Action Plan goal was to place the message board at BL Park. Seconded and motion carried.

Items on the message board would be City & Neighborhood meeting notifications of interest to residents, as well as maps of neighborhood trails, items of local importance according to our survey priorities. Next step is to have City Guidance from Park & Recreation. We will need a Design Standard, coordinating with other City-wide neighborhood parks. Then we will seek a bid based on participation of other Missoula Neighborhoods in their desire to have message boards for their neighborhood parks. Miller Creek Neighborhood will seek a grant to get started on this project.

Alex will send an email to the Leadership Team for approval, then it will be sent to the City for approval of this Action Plan.
