2. Update on 5th/6th Traffic Safety Analysis: Ben Weiss (invited)

Ben, Kevin, and Joe from Alta planning spoke with businesses impacted by the possible lane adjustments to work on some tweaks to the current version of 1-C that will satisfy all parties. One adjustment is for westbound traffic on 5th to have 2 lanes going through the Orange Street intersection and then the left lane ending as an entrance into Orange Street Food Farm.
