TO WHOM IT MAY CONCERN:

The Montana "LOCAL GOVERNMENT BUDGET ACT" is set forth in title 7, chapter 6, part 40 MCA. Pursuant to the Montana LOCAL GOVERNMENT BUDGET ACT":

- (1) Pursuant to subsection 7-6-4036(1) MCA the governing body shall fix the tax levy for each taxing jurisdiction within the county or municipality "by the later of the first Thursday after the first Tuesday in September or within 30 calendar days after receiving certified taxable values.
- (2) Pursuant to subsection 7-6-4003(1) MCA a local government shall submit a complete copy of the final budget together with a statement of tax levies to the Montana Department of Administration by the later of October 1 or 60 days after receipt of taxable values from the Montana department of Revenue.
- (3) Pursuant to subsection 7-6-4006(4) MCA the governing body may amend the budget during the fiscal year by conducting public hearings at regularly scheduled meetings.
- (4) Pursuant to subsection 7-6-4031(3) MCA establishing budget amendment procedures, a public hearing is required for an overall increase in appropriation authority; with several statutorily identified exceptions, such as for (A) emergencies pursuant to title 10, chapter 3, disaster and emergency services; or (B) section 7-6-4006 MCA for appropriation adjustments according to procedures authorized by the local government; (C) section 7-6-4011 MCA pertaining to use of bond proceeds and borrowed money; (D) fee based budgets may be authorized by the governing body to make adjustments to appropriations during the budget period; (E) section 7-6-4015 MCA payments for judgments; and (F) section 7-6-4032 MCA pertaining to emergency expenditures.
- (5) I do not find any public hearing requirement in the Montana "LOCAL GOVERNMENT BUDGET ACT" for amending/correcting a resolution pertaining to the budget.
