Update on RPNC Projects

- **St. Joseph's Playground** – New signs (paid for in part by a small neighborhood grant applied for by Rose Park NC) have been installed & the old signs taken down. Painter will follow up with St. Joseph's Principal Christina McGill to ensure she has contact information for the new Leadership Team & with Missoula PD's Community Livability Officer Ethan Smith regarding formally establishing a Neighborhood Watch for the area surrounding St. Joseph's. Gwen Jones handed out a history of her work with St. Joseph's & Missoula Catholic Schools to address temporary closures of the playground & to develop protocols to involve the neighborhood in resolving those issues and communicating any problems to St. Joseph's & Missoula PD if appropriate.
- **MCPS Projects** – Construction projects at Willard & Washington Schools are under way. Painter will follow up with Superintendent Mark Thane to request that MCPS keep RPNC's Leadership Team notified of discussion(s) regarding the disposition of the former MCPS Admin Building (215 S 6th St. W.)
- **Traffic Calming** – Julie reported no recent contact with Ben Weiss on the traffic calming project approved for Cleveland & Crosby.
