The minutes from the February 12, 2018, Leadership Team Meeting were approved.

### **Presentations:**

#### Smart 911 – Nick Holloway

- This is a nationwide program to permit more precise notifications and responses to emergency situations.
- Three prongs –
  - Safety Profiles can be voluntarily filed and maintained.
  - Emergency Alerting tailored to specific locations and situations
  - Smart Preparation
- Used widely during various events in the county ranging from lost children to fire evacuations

#### Missoula Water Utilities – Ross Mollenhauer

- The Water Utility will replace the water main on South 4th Street between Higgins and Orange Streets.
- This will occur primarily in mid-April to mid-June.
- Trees will be protected or replaced as needed.
- New surface on one block from Higgins west, and then patching for the rest of 4th Street,

#### Russell Street Project – Katie Kliez and Courtney Sprunger

- The Russell Street project will begin shortly, and some preliminary utility work is already underway.
- New east span will be constructed first, with existing Russell Street bridge restricted to one-lane one-way traffic at times.
- Architectural and Engineering drawings were distributed noting the bridge and adjacent sidewalks, as well as the Riverfront Trail and the Milwaukee Trail underpass on Russell
- There will be sidewalks along Russell on both sides.
- Public Open House, March 19, 3:00 – 7:00 at the Salvation Army Bldg on Russell with more details available at that time.

#### Preserve Historic Missoula – Page Good and Matt Morgan

- Preserve Historic Missoula seeks nominations for historic designation of public or private buildings.
- Current concerns include the Military Museum at Fort Missoula, and last WPA bldg. in the County at the County Fairgrounds.

Missoula County Public Schools – Julie Robitaille (Operating Mill Levy)

- State and local funding requires additional levy for the operation of the Missoula County Public Schools
- The vote on the levy will be by mail ballot in April.
- High School Levy totals ~\$171,000 and the Elementary (K-8) Levy totals ~ \$305,000.
- Tax increase, along with adjustment will be somewhere just over \$5.00.
- Ballot drop off at County Fairgrounds (1101 S. Ave. W.) OR Missoula County Election Office (200 W. Broadway)

Kevin Ritchlin (Willard School Construction)

- Construction has begun on the New Willard School
- Completion should occur in August in time for school to begin.
- Additional facilities include gymnasium, culinary facilities, music practice rooms, and completely modernized facilities for instruction.

- WGM is continuing to evaluate and develop design alternatives.
- Expect to have a public meeting in April to assess design alternatives
