Presentations

Long Range Transportation Plan update

Jon Sand gave a presentation on the 30 year Long Range Transportation Plan. The plan is geared towards the urbanized area and small parts of the county. Public outreach will take place in November and December. They will collect feedback from the public all over the city and various stakeholder groups, and the information will enhance goals to provide the community a healthy, safe and equity environment.

Katie Klietz, Big Sky Public Relations said after they receive and compile the feedback, projects will be prioritized and the public will be asked for additional feedback and the public will be encouraged to become involved.

The plan is to group neighborhoods with the same issues and circumstances such as transportation. This is the easiest way to get robust discussion and feedback.

North Riverside Parks and Trails

Nate McLeod, Parks & Rec. Design Specialist said the plan includes Caras, East Caras, Bess Reed, Kiwanis and Downtown Lions Parks and Ron's River Trail. He gave an overview of what the plan includes. The plans can be viewed at www.EngageMissoula.com

Bert Lindler moved to support and endorse the North Riverside Parks & Trails Master Plan. Ray Aten seconded the motion. On a roll call vote the motion passed unanimously.

Office of Neighborhoods Direction

Colin gave a brief overview of the changing ways the Office of Neighborhoods is going. A consultant has been working on a strategic assessment regarding what is working and what is not. Interviews were

conducted with many leadership team representatives and information was collected. A survey will be conducted that involves parks, open space, climate change, housing, transportation etc. This will give results on how people see their neighborhoods and what changes can be made. It will possibly grow and expand the Office of Neighborhoods which may provide more funding. The changes stays consistent with the Charter with no amendments.

Request for Work Study Funding for \$4000 from reallocated funds.

Colin said there is \$7200 in reallocated funds. The request for \$4000 is to fund three Grad students from the University. They will help compile and put together all the assessment and survey information.

Ray Aten moved to approve \$4000 from reallocated funds to fund Grad students. Bert Lindler seconded the motion. The motion passed by a voice vote unanimously.
