PRESENTATIONS Alex Apostle – Graduation Matters

Alex Apostle, Superintendent of the Missoula County Public Schools presented a video presentation consisting of the school district strength's and future needs.

Mr. Apostle discussed five goals that are currently taking place in the schools and discussed each goal.

- Achievement for graduation refined
- Implement a quality of evaluation and supervision for all staff
- Define and implement a quality professional development program that encompasses the best practices and supports the needs of all staff
- Restructure the organization to become more efficient, effective and accountable to support the goals of the district
- Evolving the community, staff, students and parents in everything the schools are doing

Mr. Apostle stated "Graduation Missoula" is a community initiative that began in January and has been adopted as a state model. The new initiative has established a 47% reduction in the drop-out rate in six months, and he discussed the high school drop-out rates.

He noted the private sector is funding the changes and not the public school funds.

Mr. Apostle stated he attends to visit all neighborhood councils to address the school system's new plan.

ON GOING BUSINESS

Community Forum Budget Resolution – Don Nicholson
Mr. Nicholson updated the forum of budget balances.

The forum discussed the budget guidelines and the resolution language.

Don Nicholson moved to adopt the resolution.

Kathy Snodgrass stated in the resolution under "Whereas" #2, it should state the small project grants will be reviewed by the Community Forum Leadership Team.

Ms. Snodgrass seconded the motion to adopt the resolution with the friendly amendment on "whereas" #2 that the small grants be reviewed by the community forum leadership team.

The forum clarified the language stating the neighborhood funds that are not used by June 30th will be transferred to the grant project funds.

Mr. Nicholson moved to call the question.

The motion to call the question passed unanimously.

The motion to approve the budget resolution with the friendly amendment passed unanimously.

There was a candidate forum that spoke about their background and why they want to serve in government. There was an update on a large grant application regarding the traffic signal boxes. They discussed traffic calming in the neighborhood. They also discussed the concerns regarding the property vacation issue on 38th St and Dore Lane.
