## About The NCS™

The National Community Survey™ (The NCS™) report is about the “livability” of Missoula. A livable community is a place that is not simply habitable, but that is desirable. It is not only where people do live, but where they want to live. The NCS was developed by the experts from National Research Center at Polco in partnership with the International City/County Management Association (ICMA) and has been administered in hundreds of communities across the United States.

Great communities are partnerships of the government, private sector, community-based organizations and residents, all geographically connected. The NCS focuses on the livability of Missoula by categorizing survey questions into the ten main “facets” of community livability shown below, which have been identified through years of extensive survey research as those that are most impactful to residents’ quality of life.

- Economy
- Mobility
- Community Design
- Utilities
- Safety
- Natural Environment
- Parks and Recreation
- Health and Wellness
- Education, Arts, and Culture ..

The report provides the opinions of a representative sample of 350 residents of the City of Missoula collected from October 23rd, 2024 to December 4th, 2024. The margin of error around any reported percentage is 5.2% for all respondents and the response rate for the 2024 survey was 11%. Survey results were weighted so that the demographic profile of respondents was representative of the demographic profile of adults in Missoula.

### How the results are reported

For the most part, the percentages presented in this report represent the “percent positive.” Most commonly, the percent positive is the combination of the top two most positive response options (i.e., excellent/good, very safe/somewhat safe, etc.). On many of the questions in the survey, respondents may answer “don’t know.” The proportion of respondents giving a “don’t know” response is shown in the full set of responses included in the “complete data” section; however, these responses have been removed from the analyses presented in the main body of the report. In other words, the tables and graphs display the responses from respondents who had an opinion about a specific item.

## Comparisons to benchmarks

NRC's database of comparative resident opinion is comprised of resident perspectives gathered in surveys from over 500 communities whose residents evaluated the same kinds of topics on The National Community Survey. The comparison evaluations are from the most recent survey completed in each community in the last five years. NRC adds the latest results quickly upon survey completion, keeping the benchmark data fresh and relevant. The communities in the database represent a wide geographic and population range. In each tab, Missoula's results are noted as being "higher" than the benchmark, "lower" than the benchmark, or "similar" to the benchmark, meaning that the average rating given by Missoula residents is statistically similar to or different (greater or lesser) than the benchmark. Being rated as "higher" or "lower" than the benchmark means that Missoula's average rating for a particular item was more than 10 points different than the benchmark. If a rating was "much higher" or "much lower," then Missoula's average rating was more than 20 points different when compared to the benchmark.

## Methods

### Selecting survey recipients

All households within the City of Missoula were eligible to participate in the survey. A list of all households within the zip codes serving Missoula was purchased from NRC's mailing vendor, Go-Dog Direct, based on updated listings from the United States Postal Service. Since some of the zip codes that serve the City of Missoula households may also serve addresses that lie outside of the community, the exact geographic location of each housing unit was compared to community boundaries using the most current municipal boundary file. Addresses located outside of Missoula boundaries were removed from the list of potential households to survey. Each address identified as being within City boundaries was further identified as being within one of the 6 areas. From that list, addresses were randomly selected as survey recipients, with multi-family housing units (defined as those with a unit number) sampled at a rate of 5:3 compared to single family housing units.

An individual within each household was randomly selected using the birthday method. The birthday method selects a person within the household by asking the "person who most recently had a birthday" to complete the questionnaire. The underlying assumption in this method is that day of birth has no relationship to the way people respond to surveys. This instruction was contained in the introduction of the survey.

### Conducting the survey

The 3,500 randomly selected households received mailings beginning on October 23rd, 2024 and data collection for the survey remained open for 6 weeks. The first mailing was a postcard inviting the household to participate in the survey. The final mailing was a reminder postcard inviting the household one final time to participate in the survey. All mailings included a web link to give residents the opportunity to respond to the survey online, as well as QR codes to further encourage participation. All follow-up mailings asked those who had not completed the survey to do so, and those who had already done so to refrain from completing the survey again.

The survey was available in English and Spanish. All mailings contained paragraphs in both languages instructing participants on how to complete the survey in their preferred language.

About 5% of the 3,500 mailed invitations or surveys were returned because the household address was vacant or the postal service was unable to deliver the survey as addressed. Of the remaining 3,315 households that received the invitations to participate, 350 completed the survey, providing an overall response rate of 11%. Of the 350 responses, 349 were completed in English and 1 was completed in Spanish. The response rate was calculated using AAPOR's response rate #2 for mailed surveys of unnamed persons.<sup>1</sup>

It is customary to describe the precision of estimates made from surveys by a "level of confidence" and accompanying "confidence interval" (or margin of error). A traditional level of confidence, and the one used here, is 95%. The 95% confidence interval can be any size and quantifies the sampling error or imprecision of the survey results because some residents' opinions are relied on to estimate all residents' opinions. The margin of error for the City of Missoula survey is no greater than plus or minus 5.2 percentage points around any given percent reported for all respondents (350 completed surveys).

In addition to the randomly selected "probability sample" of households, a link to an online open-participation survey was publicized by the City of Missoula. The open-participation survey was identical to the random sample survey, with two small updates; it asked a question to confirm the respondent was a resident of Missoula and also a question about where they heard about the survey. The open-participation survey was open to all city residents and became available on November 13th, 2024. The survey remained open for 3 weeks. The data presented in the following tabs exclude the open participation survey data, but a tab at the end provides the complete frequency of responses to questions by the open-participation respondents.

## Analyzing the data

Responses from mailed surveys were entered into an electronic dataset using a “key and verify” method, where all responses are entered twice and compared to each other. Any discrepancies were resolved in comparison to the original survey form. Range checks as well as other forms of quality control were also performed. Responses from surveys completed on Polco were downloaded and merged with the mailed survey responses.

The demographics of the survey respondents were compared to those found in the 2020 Census and 2022 American Community Survey estimates for adults in the City of Missoula. The primary objective of weighting survey data is to make the survey respondents reflective of the larger population of the community. The characteristics used for weighting were age, sex, race, Hispanic origin, housing type, housing tenure, and area. No adjustments were made for design effects. Weights were calculated using an iterative, multiplicative raking model known as the ANES Weighting Algorithm.<sup>2</sup> The results of the weighting scheme for the probability sample are presented in the following table.

NRC aligns demographic labels with those used by the U.S. Census for reporting purposes, when possible. Some categories (e.g., age, race/Hispanic origin, housing type, and length of residency) are combined into smaller subgroups.

The survey datasets were analyzed using all or some of a combination of the Statistical Package for the Social Sciences (SPSS), R, Python, and Tableau. For the most part, the percentages presented in the reports represent the “percent positive.” The percent positive is the combination of the top two most positive response options (i.e., excellent/good, very safe/somewhat safe, essential/very important, etc.), or, in the case of resident behaviors/participation, the percent positive represents the proportion of respondents indicating “yes” or participating in an activity at least once a month.

On many of the questions in the survey, respondents may answer “don’t know.” The proportion of respondents giving this reply is shown in the full set of responses included in the “complete data” section. However, these responses have been removed from the analyses presented in the reports. In other words, the tables and graphs display the responses from respondents who had an opinion about a specific item.

### **Study Limitations**

All public opinion research is subject to unmeasured error. While the methodologies employed for this survey were designed to minimize this error as much as possible, these other sources of potential error should be acknowledged, and can include non-response error, coverage error, recall bias and social desirability bias. Non-response error arises when those who were selected to participate in the survey did not do so, and may have different opinions or experiences than survey responders. For general resident surveys, where the results are meant to be generalized to the entire adult population living in households, the mailing lists based on the Delivery Sequence File from the United States Post Office may exclude certain types of housing units, such as those in multi-family buildings where mail is addressed to a named resident at the address rather than to a specific unit or where residents only receive their mail at a post office box and the geographic location of a residence cannot be determined, there may be a coverage error, although for most locations, this is minimal. Respondents may not perfectly remember their experiences in the past year (such as participation in social or civic events, for example), and for some survey items, they may answer in ways they think cast their responses in a more favorable light (recall bias and social desirability bias).

# Key Findings

## Highest-performing areas:

- Evaluations of inclusivity and engagement were comparable to those of residents in other communities across the nation, while opportunities to volunteer and participate in social events and activities exceeded the national average.
- About 8 in 10 residents rated the overall opportunities for education, culture, and the arts positively, with scores surpassing the national benchmark. Several related items also received high marks, exceeding other similar communities, including:
  - Community support for the arts
  - Opportunities to attend cultural/arts/music activities
  - Opportunities to attend special events and festivals
  - Public library services
- When evaluating general aspects of health and wellness in the community, three-fourths of residents applauded overall health and wellness opportunities in Missoula and 7 in 10 positively reviewed health services.
- The City's parks and recreational opportunities are highly valued by residents with recreational opportunities, fitness opportunities, and availability of paths and walking trails ranking higher than the national average.

## Lowest-performing areas:

- Several items related to Community Design received much lower ratings compared to the national benchmarks including overall quality of new development in Missoula, well-planned residential growth, variety of housing options, and availability of affordable quality housing indicating a potential area of opportunity.
- While residents placed high importance on the overall economy (86% rating it as essential or very important), they gave it relatively low quality ratings (26% rating it as excellent or good). These views were reflected in items such as the overall economic health of Missoula and the cost of living which both received less than favorable ratings and were also significantly lower than those of other communities. While notable, these findings align with ongoing national trends, likely driven by the rising cost of living.
- Safety scores provided by Missoula residents largely place the county on par with national averages, with some exceptions in the overall feeling of safety, police services, crime prevention, and emergency preparedness.
- As few as 3 in 10 residents gave positive marks to overall confidence in Missoula government with many aspects in this facet falling below the national average.

## Other notable results:


- When asked to indicate whether they support a reduction or tax increase to maintain current City service levels, residents' top response for reduction was financial support for community organizations (71%). Residents' top response for tax increase was access to indoor recreation activities for childcare and afterschool programs (57%).
- In addition to the standard survey questions, residents were asked to indicate how much of a source they considered the following items to be for obtaining information about Missoula and its activities. Residents indicated city website (46%), word of mouth (42%), and local/regional TV station (37%) as the top choices.
- When asked about their level of support for reforms regarding the issues of property tax reform in Montana, residents indicated support to provide an increased tax rate for luxury homes valued at more than \$2.5 million (84% strongly support or support).

# Facets of Livability

Every jurisdiction must balance limited resources while meeting resident needs and striving to optimize community livability. To this end, it is helpful to know what aspects of the community are most important to residents and which they perceive as being of higher or lower quality. It is especially helpful to know when a facet of livability is considered of high importance but rated as lower quality, as this should be a top priority to address.


## Quality and Importance by the Numbers






















